SUSPICIOUS CIRCUMSTANCES													
Narrative													

I RESPONDED TO HOPESPRING DR IN REFERENCE TO A SUSPICIOUS INCIDENT. I MET WITH THE REPORTER WHO RELATED THE FOLLOWING:

HE WAS IN THE MOTORHOME IN FRONT OF THE RESIDENCE WHEN HE HEARD LOUD MUSIC. HE LOOKED OUT AND SAW A DARK BLUE DODGE DURANGO DRIVING DOWN THE ROADWAY. IT DISPLAYED FLORIDA TAG G315RI. IT WAS PULLING A FLAT BED TRAILER. ON THE TRAILER WAS A BAND OF FOUR SUBJECTS WHO WERE PLAYING INSTRUMENTS AND SINGING. THE PASSENGER OF THE DURANGO APPEARED TO BE VIDEOTAPING THE INCIDENT. WHEN THE VEHICLE STOPPED IN FRONT OF THE HOUSE, THE REPORTER EXITED THE MOTORHOME AND APPROACHED THE GROUP. THE VEHICLE DROVE AWAY.

MOMENTS LATER A MIDDLE AGED MAN WITH A COWBOY HAT KNOCKED ON THE DOOR TO THE MOTOR HOME AND GAVE THE REPORTER A CD IN A BLACK CASE. HE STATED THAT THEY WOULD RETURN LATER TO PLAY MORE MUSIC, THEN LEFT.

THE NAME OF THE GROUP ON THE CD IS BITEBOY. ACCORDING TO THE LABEL THERE ARE TWO SONGS FROM THEIR ALBUM "UNFIT FOR HUMAN CONSUMPTION". NUMBER ONE IS "CASEY'S SONG (WINE SICK MIND)" AND SONG TWO IS "GIRL IN THE WINDOW". THE CARDBOARD INSERT FOR THE DVD/CD CASE SHOWS THE BAND'S NAME, A PHOTO OF THE BAND AND ADDITIONAL INFO ON THE BAND. THE BACK OF THE INSERT HAS THE LYRICS OF THE SONG "CASEY'S SONG". A PHOTOCOPY OF THE INSERT IS ATTACHED. THE CD AND CASE (W/ INSERT) WERE ENTERED INTO EVIDENCE.

THE REPORTER IS CONCERNED THAT THE BAND WILL RETURN AND DISRUPT THE CANDLE LIGHT VIGIL TO BE HELD IN FRONT OF THE RESIDENCE LATER THIS EVENING. I HAVE MADE THE ON DUTY SUPERVISORS AWARE OF THE POSSIBILITY AND WILL ALSO INFORM THE NIGHT TIME WATCH COMMANDER.
